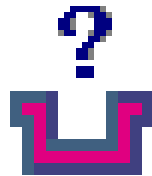

1 Introduction

1.1 Overview

MQWhat is a great tool for documenting which MQ components are installed and active on a particular server. Since, MQ component information is contained in various files and / or outputted by MQ programs, MQWhat is designed to collect and summarize the MQ information and present the information to the user's screen in a concise manner.

On Unix / Linux, MQWhat is supplied as a Unix Shell script and on Windows, MQWhat is supplied as an executable.

2 Installing MQWhat

This section describes how to install Capitalwares MQWhat.

2.1 Windows Installation

To install MQWhat on Windows, do the following instructions:

- Run the install program called: **mqwhat-setup.exe**
- The installer follows the standard Windows install procedures and provides default values for the user.

2.2 Unix and Linux Installation

To install MQWhat on Unix or Linux, do the following:

1. ftp or copy the selected mqwhat.tar.zip file to the target platform
2. Unzip the mqwhat.tar.zip to an appropriate directory with the following command:

```
unzip mqwhat.tar.zip
```

3. Change directory to *Capitalware/MQWhat/*
4. Next, do the following command:

```
chmod +x *.sh
```

3 Starting MQWhat

This section describes the various ways that the MQWhat can be started. Currently, MQWhat via WebSphere MQ's triggering system, manually or by a scheduling package.

3.1 Windows

3.1.1 Manual Execution

MQWhat can be manually started from a Command Prompt. First change to the MQWhat directory (i.e. C:\Capitalware\MQWhat) and then type *MQWhat.exe* and then press *Enter*.

3.1.2 Scheduled Execution

MQWhat can be setup to be run under a scheduling package. (For example, Windows 2003 **Scheduled Task** service.) You may prefer to have MQWhat executed daily. Therefore, use the scheduling package's tools to setup the necessary parameters for daily execution.

3.1.3 Command-line parameters

3.2 Unix / Linux

3.2.1 Manual Execution

MQWhat can be manually started from a Shell Prompt. First change to the MQWhat directory (i.e. Capitalware/MQWhat) and then type *MQWhat.sh* and then press *Enter*.
